SUBJECT: 2018 Land Use Referral Review – Land Disturbance Summary

Please find attached two summary spreadsheets. The first spreadsheet titled "Approximate Areas of Land Disturbance", summarizes the approximate areas of land disturbance within Cherry Creek basin, tabulated from the land use referrals received during 2018; by Land Use Category and by Agency. At the bottom of the spreadsheet is the total land disturbance data tabulated for the individual years 2014 through 2018. It should be noted that this summary data:

- Is based on the land use referral submittals received and reviewed by the Authority.
- Includes only those referral submittals related to site plan submittals. (i.e.: referral submittals including documents for review such as sketch plans, plats, plat amendments, planned development plans and rezoning amendments were not included in this summary).
- Tabulates the disturbance areas which are the reported lot, tract or parcel boundary area size and are not necessarily the specific area(s) disturbed by grading or construction.
- Includes a few residential submittals reviewed which are believed to be a part of a larger subdivision proposed for built out over a multi-year period.

Four large tract preliminary document submittals were received and reviewed that are anticipated to develop over a multi-year period. These developments are identified as:

- 1. City of Aurora Kings Point Filings 1 and 2. Area ≈ 631 acres.
- 2. City of Castle Pines The Canyons Subdivision. A ≈ 1,880 acres.
- 3. Douglas County Canyons South Subdivision. A ≈ 391 acres.
- 4. Douglas County Legacy Pines Subdivision. A ≈ 244 acres.

The second spreadsheet titled "Annual Summary of Authority 2018 Land Use Reviews", summarizes the total number of land use referrals reviewed by the Authority during 2018; by Land Use Category and by Agency. At the bottom of the spreadsheet is the referral review summary detail tabulated for the individual years 2014 through 2018.
